JOINT COMMUNIQUÉ OF THE BILATERAL PERMANENT WORKING COMMISSION BETWEEN THE HOLY
SEE AND THE STATE OF ISRAEL

The Bilateral Permanent Working Commission between the Holy See and the State of Israel has held a Plenary meeting at the Vatican today, Wednesday 28 May 2008, for the purpose of advancing the negotiations pursuant to Article 10 § 2 of the *Fundamental Agreement between the Holy See and the State of Israel* (30 December 1993).

The Delegation of the Holy See was led by Monsignor Pietro Parolin, Under-Secretary for Relations with States at the Secretariat of State, and was composed also of the following Members:

The Delegation of the State of Israel was led by Mr. Aaron Abramovich, Director General of the Ministry of Foreign Affairs, and was composed also of the following Members:

The next meeting of the Plenary will take place during the first half of December this year, in Israel, and in the meantime the Commission will continue upon its task at the "working level".
