COMMUNIQUÉ OF THE PRESS OFFICE OF THE HOLY SEE: APPOINTMENT OF THE NEW PRESIDENT OF THE SUPERVISORY BOARD OF THE INSTITUTE FOR THE WORKS OF RELIGION (I.O.R.)

The Commission of Cardinals for the Institute for the Works of Religion (I.O.R.) has made an appointment, in accordance with the Institute's Statutes, of the new President of the Supervisory Board in the person of **Ernst von Freyberg**. The other four members of the Supervisory Board all remain in office.

This decision is the result of extensive evaluation and a series of interviews that the Commission of Cardinals has conducted, with the constant support of the Supervisory Board.

This painstaking and detailed process lasted for some months, making it possible to assess a number of candidates of professional and moral excellence, with assistance from an independent international Agency that is a leader in the selection of top executives.

The Holy Father has closely followed the entire selection process leading to the choice of the new President of the Supervisory Board of the I.O.R., and he has expressed his full consent to the choice made by the Commission of Cardinals.
